## A MESSAGE FROM OUR PRESIDENT: From WA3CPO, Gary Blacksmith, MD

The next meeting of CPRA will be a tour of the 193<sup>rd</sup> Air National Guard at the Harrisburg International Airport on Wednesday, September 25<sup>th</sup>. The meeting originally scheduled for Thursday, September 26<sup>th</sup> 2013 at The Wharf Bar & Grill has been <u>cancelled</u>. See all the details in the special meeting notice below!

#### **MISC. TECHNICAL STUFF:**

Emergency power is being planned for several mountain top sites. This will be discussed in detail at the next regular meeting. We are waiting for an administrative approval for work to begin at Blue Mountain for connection to an existing generator.

PEMA HQ had interference to a portable UHF repeater last week. Tim Shingara brought his spectrum analyzer and found that an unknown signal was present from 443 to 447 Mhz. In that signal were square waves traveling from 443 to 447 Mhz. At twice that frequency a similar pattern was seen. It was identified as part of the State 800 Mhz radio system. These radios were located in the next room. It was concluded that the spurious emissions were likely within FCC specs.

Outdoor CAT5 cable at Mt Holly was discovered to be defective. The cable ran from the upper part of a building 80 ft. in the air to the safety rail and then down to a transmitter attached to a support pole. The cable was exposed to intense UV radiation from the sun and was deteriorating. It was turning green and the jacket was decomposing and flaking off. The braid was visible and was allowing water to penetrate the cable. The water ran down the inside of the cable and caused the Ethernet connection to short. The transmitter was damaged and had to be replaced. Other cable runs may have this cable and they need to be replaced. The manufacturer will replace the cable and damaged equipment.

The IRLP lost its internet connection via PEMA HQ. NOROC, a wireless internet service provider, supplies this service free of charge for the club. The internet connection was changed to an alternate gateway. This failure could be more defective cable or some other cause. It is under investigation.

Four 24 port switches were installed at PEMA HQ. A different gateway is available on each switch. This allows someone to quickly change gateways in the event of a failure. Each gateway has a DHCP server. Static addresses are not needed. Most of the state computers cannot have a static address installed.

#### CAMERA SYSTEM:

The camera system has been upgraded recently. We have 10 cameras on this network and an additional 10 cameras on separate networks.

The total is now 20 cameras viewing mountain top locations. They may be viewed using <u>Google</u> <u>Chrome not Internet Explorer</u>. Go to <u>HTTPS://airvision.kb3hjc.net:7443</u>. Click on "proceed anyway". (In order to obtain a security certificate you must register and pay a FEE. We are not in a position to pay a fee.) Username: cpin Password: cpin

Click on live view to view the cameras and select an individual camera or a group of cameras. Please do not logon and watch for days. This ties up assets and the available bandwidth is metered. Waggoner's Gap and SPARC (Manheim) are not illuminated at night...enjoy.

The Cumberland County EOC has 32 or more flat panel TVs. There are 32 inputs and each TV can select a specific input. One of the inputs is the RACES room. A computer is being installed in the RACES room to connect to the video server located off site.

Any of the cameras can be selected to be displayed on the flat panel TVs. We are using an HDMI connection and cameras capable of 720p. None of the cameras available to the County are in high definition. The quality of the picture should be impressive.

#### FIELD DAY 2014:

CPRA Field Day 2014 is a possibility. The next regular meeting will include a discussion about the feasibility of this becoming a reality. This will require a commitment from the membership. The next General CPRA meeting will be held on Thursday, October 17, 2013

#### LINKING PROJECT:

The linking project is gaining momentum. Several UHF repeaters will be linked soon.

## ATLANTIC DIVISION ARRL INFORMATION FORUMS:

Dear ARRL Affiliated Club Representative/Newsletter Editor:

Through our travels and discussions throughout the Atlantic Division, division leadership has heard from many club officers of the need to share ideas about club issues and from club newsletter editors about the difficulty in gathering information for club newsletters. To that end, we have made arrangements for several amateur radio discussion forums to help that process. Current areas available for discussion are:

## Amateur Radio Discussions Forum - general amateur radio discussions.

ARES - discussion of topics of interest to the Amateur Radio Emergency Service® (ARES). (ARES is a trademark of the ARRL). Discussions could include recruiting new members, how to work with local emergency management officials, what type of drills are effective, how to motivate volunteers, what type of training is necessary, succession planning... Files can be shared with other participants that might include Power Point presentations used for meeting topics and training.

**Club Management** - discussion of club management issues such as meeting topics, meeting formats, elections, recruiting, classes, succession planning, etc. Files can be uploaded to be shared with other participants of club presentations or photographs of club events. One common thread we've heard from club officers is the issue of what topics do we present at club meetings? Why not share with other participants what topics were successful and what topics weren't?

**Club Newsletters** – this is a place where newsletter articles can be uploaded to be shared with other club newsletter editors. This also can be a place to put news releases for other clubs to pick up for publication in their club's newsletter - this could include scholarship programs, hamfest announcements, local club events (past and upcoming), new club officer election results, etc...

**Hamfest Management** – For new or experienced hamfest organizers. Many clubs are using hamfests for club revenue. Hamfest attendance is declining at many hamfests, how can we reverse the trend? What other ways are there for clubs to build revenue outside of hamfests? What is the difference between an ARRL Affiliated Hamfest and an ARRL Convention? This is the place to shares ideas on hamfest organization/management.

If there is enough interest for forums with new topics, new forums can be set up.

Our plan is that each forum will have one or more subject experts to help moderate the forum. The moderator(s) will help facilitate the discussions in the forum to keep it flowing and on topic. If you are interested in serving as a moderator, please send an email to <u>moderators@atldiv.org</u> with the name of the forum you'd like to help moderate and a list of your qualifications.

To participate in the forums, you will be asked to register your first initial + last name as your log-in.
